## **Minutes:**

**9.03.1** The Vice-Chancellor made his observations on the various activities of the University since the last meeting of the Academic Council held on 28.03.2011. The House in overall placed on record its appreciation for the performance highlights reported. The following observations have been made in particular by the Hon'ble Members.

- **9.03.2** <u>Prof Ravi Srivastava</u> mentioned that the heart and soul of the Vice-Chancellor was seen in the presentation. The achievements made by the University with a very small and committed team are commendable and congratulated the team for overcoming formidable challenges.
- **9.03.3 Prof Neelima Deshmukh** remarked that the University from the beginning has made very steady state of progress.
- **9.03.4 Dr. GS Yonzone** stated that the Academic Council would always be with the Vice-Chancellor for his thoughtful activities. He stated that the number and nature of activities of the University over a period of time increased very rapidly. In spite of the fact that the actual manpower is very less, the ideas of the University and its achievements are very vast.
- **9.03.5 Prof YR Reddy** described his experience in setting up of University of Hyderabad. It took them at least 20 years to reach a level. He mentioned that in the initial years of formation, the Vice-Chancellor of Hyderabad University wrote to top-class people in the country requesting them to join the University and accordingly brought the best brains for the University. To set Central Instrumentation facilities alone it took more than 7 years. In the case of Sikkim University it has both locational advantages and disadvantages. He urged the Chairperson to look for new faces around the country and should write and trap leaders for developing each of the discipline. While the projections of Sikkim University are very high, with a faculty members at the Assistant Professors level only, it would be rather difficult for it to achieve them. He further suggested that the Vice-Chancellor can write to other Universities for top-class faculty members and can even recruit them without undergoing formalities like interview. Mediocre faculties are always dangerous. Sikkim University should go all out to attract eminent faculty from outside the usual system. Mere advertising for recruitment would not help and the University has to take some amount of risk to do this.

As far as the Central Instrumentation facilities are concerned he mentioned that distributed power system is very much essential which the University should consider.

- **9.03.6 Dr GS <u>Yonzone</u>** mentioned that the University may also consider that after the term of office of the present Academic Council is over, the members may be invited in visiting positions.
- **9.03.7 Prof JP Sharma** mentioned that what Sikkim University has achieved so far many Central Universities could not even dream of. This he knows as he has been in Academic Councils of a number of Central Universities. The University is following total transparency for which he would like

to award ten out of ten to the Vice-Chancellor. He further complemented that from Sikkim University he had learnt a lot.

**9.03.8** <u>Prof. Neelima Deshmukh</u> placed on record her appreciation for the excellent and stupendous work done by the Vice-Chancellor and his team. She desired to know as to how long the members would be associated with the University for future.

**9.03.9 Prof Tista Bagchi** stated that other Vice-Chancellors are also appreciating the dynamism of the VC of Sikkim University. She enquired as to why there was uniform for the students in the affiliated colleges. She hoped that these uniforms primarily meant to bring in discipline actually have not come in the package where there will be undue repressions.

**9.03.10** The Chairperson while concluding the discussions mentioned that in Sikkim University everyone is working very hard and with dedication. He stated that his father was a strict disciplinarian and even hair cut of his children was done in a highly disciplined manner. In the same fashion the colleagues of VC in the University including in the faulty and management are disciplined, and work with conviction. He remarked that once the Private Secretary to the Hon'ble Minister for Human Resource Development in New Delhi remarked that Vice-Chancellor of Sikkim University is the only Vice Chancellor in the entire country who has no complaints when he meets the Minister. He only mentions about the achievements and the challenges. The Chairperson apprehended that the University may not get this type of national composition in the second Academic Council when it is reconstituted. He mentioned that most of suggestions made by the Hon'ble' Members so far have been implemented and we will do it in future also. He also stated to get the best manpower in the University, it does layers and layers of short listing before selecting a candidate for recruitment, be it teaching or non-teaching. As regards the issue of uniforms in the affiliated affiliated colleges, the University was in no way involved as it was the decision of the said college to implement wearing of uniform.

**9.05.1** The Action Taken Report on the Minutes of the last meeting held on 28.03.2011 which was enclosed as Annexure AC VIII- 02 to the agenda was considered by the house and discussed. The following remarks have been made by the Hon'ble members during discussion.

**9.05.2 Prof AR Reddy** enquired that in the case of an integrated programme when a student exits at B.Sc level what degree she/he will get. If such a student gets out of B.SC from Sikkim University and applies for a particular M.Sc in some other University will it be possible for her/he to enroll there? He further enquired as why the University thought it fit to introduce B.Sc-M.Sc integrated.

**9.05.3** To this <u>the Chairperson</u> replied that the National Policy on Education is silent on such issues. In fact, even some of the basic parameters of the University and those of Government of Sikkim themselves did not match. On Unitization of B.SC - M.Sc integrated into M.Sc course the Chairperson replied that curriculums are different and independent.

**9.05.4 Prof Reddy** mentioned that after B.Sc the student can choose any PG degree. It should have provisions for lateral entry also. By this students with B.Sc from other Universities would join Sikkim University for M.Sc course. To this the Chairperson mentioned such things are already implemented in Sikkim University and also the case for credit transfer which also requires larger national debate. He further stated that in the case of integrated courses the students will have a separate campus, mentor, mess, lab etc so as to expose them to all kinds of scientific environment. Sikkim University should create such an atmosphere for students of integrated courses to expose them all times in science environment. By this the students will live and work in scientific environment.

**9.05.5** <u>Prof Neelima Deshmukh</u> enquired as to what action the University has taken on re-naming of itself as the Central University of Sikkim rather than just calling it Sikkim University. This was

essential as there are universities like Vinayaka Mission Sikkim University. Prof JP Sharma also joined the issue in the discussion.

<u>Prof Deshmukh</u> mentioned that the University can write to the State Government mentioning that SU is created by an Act of Parliament and the name was coined in the said act. Simultaneously the University can also write to Ministry of Human resource Development. If the University desires to continue with the present name of "Sikkim University" it can mention in all places below the name with the sentence "[established by an Act of Parliament]"

**9.05.06 <u>Prof JP Sharma</u>** even suggested that the University can write to Vinayaka Mission Sikkim University as to why they copied the name from Sikkim University and start legal actions.

**9.05.07** <u>The Chairperson</u> assured the members that their suggestions would be looked into. After this, the House confirmed the Action Taken Report placed before it.

Prof Ravi Srivasatava observed that the formation of IQAC is very vital and from the very beginning it is essential to have faculty-students feedback in making the teaching-learning process accountable and useful. It is essential to design Students Participation in Learning Process (SPLP) at this stage only.

In this case the same data were published by two research students in the same international journal on different dates. One way to curb the unfair means in research papers is that the University may obtain a

declaration that "This work is original and not published elsewhere". He also mentioned that the while gross plagiarism can be detected easily, finer plagiarism cannot be.
